This letter is to inform you that as part of a rebranding effort to reflect the Energy Transfer family of names, Sunoco Partners Marketing & Terminals L.P. will change its name to "Energy Transfer Marketing & Terminals L.P." effective March 1, 2022.

After the name change is effective, Energy Transfer Marketing & Terminals L.P. may use the trade name "Energy Transfer Refined Products" in conducting its refined products business, and the trade name "Energy Transfer NE NGL" in conducting its natural gas liquids business. The trade names will be reflected as either Energy Transfer Marketing & Terminals L.P. dba Energy Transfer Refined Products or Energy Transfer Marketing & Terminals L.P. dba Energy Transfer NE NGL. You may see these trade names noted on the Energy Transfer website and on Energy Transfer Marketing & Terminal L.P.'s contracts and correspondence, but our invoices will not reflect these trade names.
