As you may be aware, Energy Transfer LP (“Energy Transfer”) acquired Enable Midstream Partners, LP (“Enable”), effective on December 2, 2021.

We are pleased to announce that, effective October 1, 2023, Enable and multiple Enable subsidiaries will be merged into ET Gathering & Processing LLC, a newly created entity. This letter serves as notice of certain changes in connection with this consolidation.
